On Monday, June 2 the Board of Supervisors gave final passage to an appropriation of over \$10,000 for the sheriff's office, to fund deputy sheriffs; Alioto signed this into law on June 5. Also, the Board passed unanimously on setting up a special committee to advise the Human Rights Commission on gay concerns. Even though this sounds good on the surface, it will pit the gay community against other minority groups with whom we have been trying to build a coalition for a number of years. There is no special advisory committee for blacks, Chicanos or any other minority.

On June 9, the Board gave final passage to the appropriation of \$25,000 for voter registration funding by a vote of 7-4. Noes were cast by Feinstein, Barbagelata, Kopp, and Nelder. As we prepare for press, the Mayor has not taken action on this measure which would allocate payment of 35¢ per valid registration turned in by deputies. The Mayor has until June 20 to act. If you would like to register voters and maybe get paid to do it, call me and I will set up a class for you to learn how - call 431-3344.

This motion was immediately seconded by RV. REED, who argued in favor of it on very emotional grounds - saying that discrimination on this basis or any basis not related to ability to do the job is shameful. Reed continued, recalling incidents of teenage gangs that would beat up people who they felt were gay - explaining that it was just one more deplorable effect of prejudice.

Next, it was moved and seconded that the inclusion of 'sexual orientation' in the Board's nondiscrimination policy be taken up immediately, as an emergency measure. The motion passed, 7-0.

The original motion to amend the antidiscrimination policy was then put to the question, and also passed, 7-0

This was indeed a milestone for academic freedom and civil rights in general. Thank you, DR. HOPP and RV. REED, for your clear thinking. Also, thank you, Howard and the rest of B.A.G.L. and G.T.C., for showing the Board of Education that the issue of civil rights for gays means the issue of civil rights for very large numbers of gifted moral citizens.
